## Lulu Auditions FAQ

### **How early do I need to arrive prior to my scheduled audition?**

Please do not arrive more than 10 minutes prior to the audition session time for which you signed up. To sign up, please [click here](#).

### **What should my child wear?**

The character's costume is simple denim with a t-shirt, so participants can wear whatever makes them comfortable. The audition will require running; therefore, children should wear appropriate shoes to run in safely.

### **What do we need to bring?**

Please bring a current photo and resume, if available. When your audition time is confirmed, you will also receive several documents to review and sign and bring to the audition with you.

### **Do I get to watch my child audition?**

Children will be brought into the audition room with Center staff and parents will be asked to wait outside for the 5-minute audition.

### **How long will the audition take?**

Each audition is expected to take approximately 5 minutes, however it may take some time to get to your child. Please be prepared to stay at the audition for approximately 1 hour.

### **Where do I go when I arrive?**

We recommend [Durham County Judicial Center Parking Deck](#) (510 South Dillard Street), the parking garage at [Unscripted Durham Hotel](#) (202 Corcoran Street), or one of the [City's other parking decks](#), such as [Church Street Garage](#) or [Corcoran Street Garage](#), in Downtown Durham for this event. Do note that some of these garages may sell out.

Additionally, a limited amount of on-street parking options can be found by [clicking here](#). Because this Friday is considered a holiday by the City of Durham, all on-street parking will be free and will have no time limit.

Available parking will be three to five blocks further from DPAC than where you might have parked on previous visits.

Please enter on the Blackwell Street side of the building, where you'll enter the Entry Lobby. Please note this is at the front of the building, but on the opposite side of the BCBSNC Ticket Center at DPAC. A staff member will be stationed at this entrance to check you in for the audition.

### **Who decides which actresses will be cast?**

All casting decisions are made by the company representing WAITRESS.

### **If my child is cast, what is the expectation?**

Your child should be available May 1-6, 2018 at DPAC for performances of Waitress. The part appears in the finale so children should be prepared to be at the Center until at least 3 hours after the show begins. Additional information will be provided to those selected by the company of Waitress.

**What if my child cannot make one of the scheduled performances but would still like to audition?**

Each actress should be prepared to step in at any of the eight scheduled performances. Any conflicts should be disclosed at the audition.

**When will we be notified of casting?**

The production office will contact the parent or guardian by phone or email within two weeks of the audition. The names will also be announced on the DPAC Facebook page and website.
